A natural outcome of the emerging pledge and review approach to international climate change policy is the interest in comparing mitigation efforts among countries. Many will want to know if similar or “peer” countries are undertaking (or planning to undertake) “comparable” effort in mitigating their greenhouse gas emissions.

Moreover, if the aggregate effort is considered inadequate to address the risks posed by climate change, this will likely prompt interest in identifying opportunities for greater effort by individual countries—an assessment that requires metrics of effort and comparisons among countries.

This event presents methods for evaluating NDCs’ emission reduction efforts and assesses their economic costs, with actual costs shown to be higher than least-cost mitigation measures. The panel will focus on how to reduce compliance costs, highlighting the value of technology & social innovations.

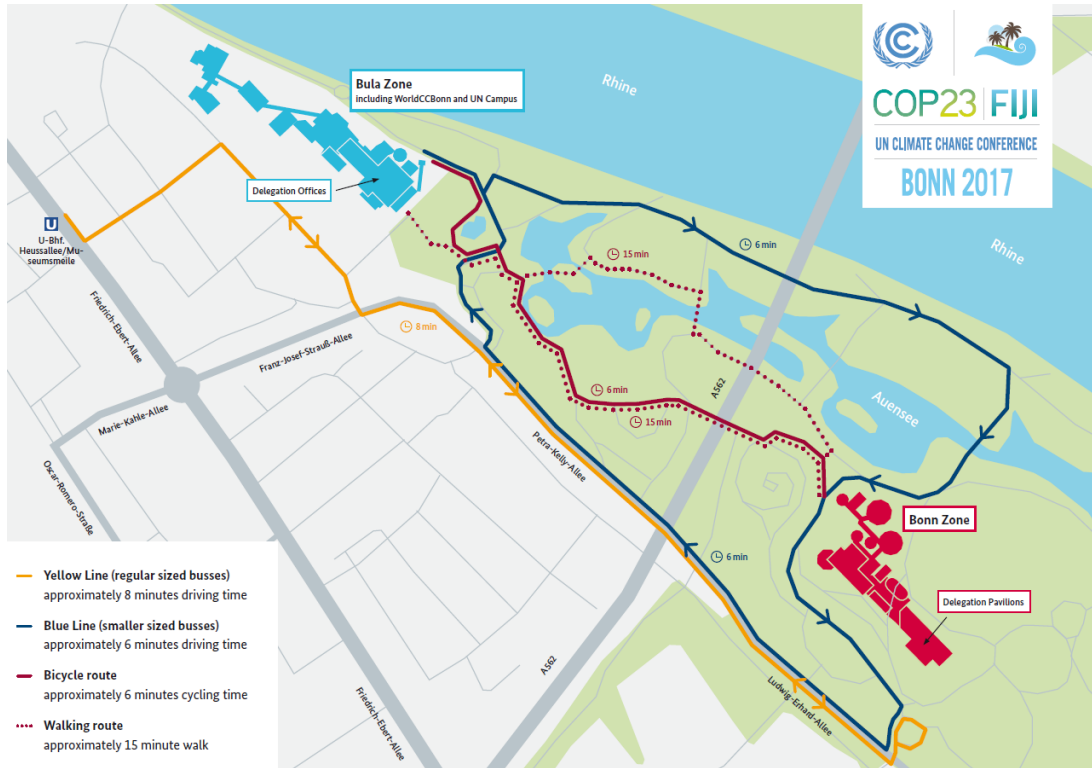
